None of the user's personal data will be exchanged, published without his knowledge, transferred, given, or sold in any format whatsoever to a third party. Only the hypothetical sale of ugcb.net and their copyrights would allow the transmitting of the above information to a possible purchaser who would, in turn, have the same duties regarding the keeping and modifying of data collected from users of the ugcb.net site.
